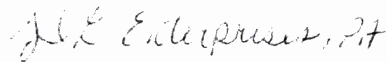

NOTE A: Nature of Activities and Significant Accounting Policies

Missionary Air Group, Inc. (the Organization) exists in order to establish, operate, and fund missionary aviation bases in foreign countries for the purpose of providing medical evacuation airlift, medical services, and the conduct of humanitarian relief, ministry operations, and the support thereof. The Organization is based in Alamance County, North Carolina and relies on private grants and donor contributions as its principal source of revenue.

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash receipts and disbursements basis of accounting, which is a comprehensive basis of accounting other than generally accepted principles. That basis differs from generally accepted accounting principles in that contributions are recognized when constructively received. Payments to vendors are recognized when paid instead of when goods or services are received. Purchases of property and equipment are capitalized and depreciation expense is recognized over the assets' useful life.

Basis of Presentation

The Organization is required to report information regarding its financial position and activities according to two classes of net assets: net assets with donor restrictions, and net assets without donor restrictions.

Property and Equipment

Property and equipment are valued at cost less accumulated depreciation. It is the Organization's policy to capitalize property and equipment with an original cost in excess of \$1,500. Maintenance and repair costs are charged to operations as incurred. Gains and losses on disposals are reflected in income. Depreciation on assets is computed using the same method used for tax returns.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Contributions

The organization reports contributions received as with donor restriction or without donor restriction support depending on the existence and/or nature of any donor restrictions. Contributions are then reclassified to unrestricted net assets upon the expiration of the restrictions.

Donated Supplies, Services, and Equipment

Non-cash donations are recorded at their estimated fair market value at the date of the donation. Such donations are recorded as unrestricted support unless the donor has restricted the donated asset to a specific purpose. Assets donated with explicit restrictions are recorded as restricted support. During 2019 there were no significant donations of supplies, services, or equipment.

Restrictions on Net Assets

Net assets with donor restrictions represent funds available for designated projects such as buildings and aircraft fleet upgrades as well as donations for specific missionaries.

Expense Allocation

The costs of providing various programs and activities have been summarized on a functional basis in the statement of activities and detailed in the statement of functional expenses. Accordingly, certain costs have been allocated among the various programs and supporting services benefited. Expenses that are readily identifiable with a program are charged to that program. Management and general expenses are those expenses that are not directly identifiable with any other specific program but provide for the overall support and direction of the Organization.

Income Tax Status

The Organization is a nonprofit organization as described in Section 501(c)(3) of the Internal Revenue Code and is exempt from federal and state income taxes. Contributions to the Organization qualify for the charitable contribution deduction under Section 170(b)(1)(A).

Advertising

Advertising costs are expensed as incurred. Advertising expense was \$1,347 for the year ended December 31, 2019.

Subsequent Events

The Organization evaluated the effects subsequent events would have on the financial statements through August 2, 2020 which is the date the financial statements were available for issuance.
